**A BYLAW TO PROVIDE FOR THE ENFORCEMENT OF BYLAWS BY MUNICIPAL TICKET INFORMATION**

---

WHEREAS Part 8, Division 3 of the *Community Charter* authorizes the Council to, by bylaw:

1. Designate those bylaws, which may be enforced by means of a form of ticket prescribed by regulation under Section 273;
2. Designate bylaw enforcement officers for the purpose of enforcing bylaws by means of a prescribed form of ticket;
3. Designate an offence against a bylaw by means of a word or expression on a ticket; and
4. Set fines, not exceeding \$10,000.00 for contraventions of designated bylaws.

NOW THEREFORE the Council of the Town of Sidney in open meeting assembled enacts as follows:

1. This bylaw may be cited as the Town of Sidney "**Municipal Ticket Information Bylaw No. 1975, 2010**".
2. The bylaws listed in Column 1 of Schedule 1 to this bylaw may be enforced by means of a ticket in the form prescribed for the purpose of Section 273(a) of the *Community Charter*;
3. The persons appointed to the job positions or titles listed in Column 2 of Schedule 1 to this bylaw are designated as bylaw enforcement officers pursuant to Section 264(b) of the *Community Charter* for the purpose of enforcing the bylaws listed in Column 1 of Schedule 1 opposite the respective job positions;
4. The words or expressions set forth in Column 1 of Schedules 2 through 11 to this bylaw designate the offence committed under the bylaw section number appearing in Column 2 opposite the respective words or expressions;
5. The amounts appearing in Column 3 of Schedules 2 through 11 to this bylaw are the fines set pursuant to Section 265 of the *Community Charter* for the corresponding offences designated in Column 1;
6. This bylaw shall take effect upon the date of its adoption; and
7. That the Town of Sidney "Ticket Information Bylaw No. 1265, 1995" and all amendments thereto are hereby repealed.
