GENERAL REGULATIONS:

In consideration of the Town of Sidney agreeing to undertake any works where there are no connection charges and or fees fixed by Bylaw, the Applicant agrees to the following terms and conditions:

1. Before commencement of the Works, the Applicant agrees to pay the Town a deposit of \$_____ based on the estimate prepared by the Engineering Department. Once the Works are complete, the Engineering Department shall determine the actual costs and should the actual costs be more than the deposit amount, the Applicant shall immediately remit the difference to the Town. Should the actual cost be less than the estimated amount, the Town shall refund the difference;
2. The Applicant agrees that the Town and its agents, servants and workers may enter upon the property, with or without vehicles, equipment and machinery, at all times and in such a manner as may be reasonable or expedient for the purpose of performing the Works and other incidental work;
3. The Applicant hereby releases, indemnifies and saves harmless the Town and its officers, elected officials, employees, agents, contractors and others from any and all claims, demands, actions, suits, proceedings and losses of whatever kind, whether arising in law or in equity, which may result from or be connected with or in any way arise out of any act, omission, default or negligence of the Town in relation to this application or the Works or any part of them; and
4. If the Applicant is a corporation, the person signing this application on behalf of the Owner represents and warrants that they are authorized to make this application and bind the Owner by their signature.

¹ Over 100mm (4") in size of connecting pipe, and prior to commencement of the works a deposit will be required based on an estimate prepared by the Town of Sidney Engineering Department. Actual costs above or below the deposit will be charged or refunded accordingly.

² Over 25mm (1") in size of connecting pipe, and prior to commencement of the works a deposit will be required based on an estimate prepared by the Town of Sidney Engineering Department. Actual Costs above or below the deposit will be charged or refunded accordingly.

Over 50mm (2") water meter a charge based on the actual cost to purchase the meter by the Town of Sidney will be required.
